## Zambrero / Perth Glory 2025/26 Season Ticket promotion: Terms & Conditions of Entry

- Information on how to enter and prize details form part of these terms & conditions (**Terms**).
  Participation in this Promotion is deemed acceptance of these Terms. This Promotion is conducted by Zambrero Pty Ltd of Suite 1, Level 11, 1 Macquarie Place Sydney NSW 2000 (the "**Promoter**").
- This Promotion commences at 9am on Sunday, 26 October 2025 and closes at 11:59pm on Sunday, 31 May 2026 ("Promotional Period"). Entry periods for each prize and draw dates are set out in clause 10 below.
- 3. Entry is open only to legal residents of Western Australia aged 18 years and older. Directors, officers, management, employees, suppliers (including prize suppliers) and contractors (and the immediate families of directors, officers, management, employees, suppliers and contractors) of the Promoter and of its related bodies corporate, and of the agencies and companies associated with this Promotion are ineligible to enter.
